

# SCOPE OF STUDY

- Scope Statement: The purpose of the disparity study is to examine the extent of participation of minority and women owned businesses ("MWBEs") in GDOT's DBE Program (federal contacts only) to determine if there is a disparity between the number of MWBEs that are "ready, willing, and able" as vendors in 1) Construction 2) Professional Services 3) Manufacturing/Suppliers and the dollars spent by GDOT with those MWBEs.
- Study Period: FY2012-2014
